VI. Treasurer - Charles

- A. 2023 Budget Discussion
 - 1. Did not raise annual fee
 - 2. Waste collection goes up 1.5% per contract but after 2023 it could go up significantly. Inquiring about a contract extension.
 - 3. Lawn Care reduced slightly since M&C is cheaper and covers more than what we currently get
 - 4. Increased pond maintenance since we've had increases from Solitude and we have had repairs / fish stocking
 - 5. Increased egg hunt and 4th of July because they were relatively low and want to take into account inflation
 - 6. Capital projects would hope there aren't many that are large expenses so relatively low budget there
 - 7. Move to accept the budget for 2023 accepted
 - 8. Move to keep the \$400 fee the same next year and send out notice in December accepted
